- \_\_\_\_\_ 9.) Government issued, state or federal, picture ID. (Example: **Drivers License, Military ID, State ID card, or Merchants Mariner Document {Z-Card}**)
- \_\_\_\_\_ 10.) Have **never been convicted** by any court-including military court-for any offense other than a minor traffic violation. **{Misdemeanor convictions upon review}**
- \_\_\_\_\_ 11.) Have had **NO DUI's IN THE PAST 36 MONTHS**
- \_\_\_\_\_ 12.) Have a minimum of 12 months seetime. (Seetime may be accepted from a candidate from the US Army if they were a Tug Master on board small boats.)

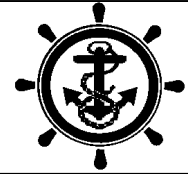
